Profile

Ian Taylor & Co. was founded in Chile in 1965 by Mr. Ian B. Taylor, with the purpose of offering quality agency services to foreign and national ship owners. Its first office was located in the port of Valparaiso and shortly after, a commercial office was established in Santiago.

Over the years, the Company received the acknowledgement of ship owners, who welcomed its reliability, efficiency and loyalty due to which the number of Principals and ships attended increased significantly. This growth brought as a consequence, the need to expand geographically and soon port agencies were established in Talcahuano, Coronel, Antofagasta, Mejillones, Iquique, Arica, San Antonio and Punta Arenas in Chile. At the same time, the requirements of some of these Principals inspired the entry into ship agency activity in Peru and later in Ecuador.

As a complement to its agency activities, Ian Taylor & Co. developed a stevedoring division, attending to a wide variety of cargoes at every major port in the countries in which it operates. Today, the company acts in stevedoring of bulk cargoes, cars, containers, project cargoes and steel.

The company also operates a fleet of tugs and launches to give service to its principals and has tugs stationed in the ports of Callao and Paita in Peru and San Antonio and Coronel in Chile.

Ian Taylor & Co. is a privately owned group which is fully independent of any outside shareholding. This independence allows the Group to offer services to the majority of the world's Ship owners and Operators. In the three countries in which it operates, the Company employs over 200 people in Agency and related services.

As a company in the services industry, the main objective of all the personnel in the Ian Taylor Group of companies is to ***provide excellent service to all our customers.***

Bunker trading; Admiralty Charts sales; Project Cargo Management and Logistics.


In 2001, these services were certified to the ISO9001:2000 standard. In 2007, the Company was certified to ISO 14001 and 18001 (OHSAS).
